### Graduate Nursing Programs

The University of Alberta Faculty of Nursing invites applications for the Master of Nursing and PhD in Nursing programs.

The aim of the MN program is to prepare nurses to function as advanced-level practitioners in hospital, community, and/or educational settings. Student programs are designed on an individual basis within the MN curriculum framework. A thesis is required of all students. A Certificate in Nurse-Midwifery mat be taken in conjunction with the MN program and a concentration in Nursing Administration is also available. Students are admitted into the program in January and September (application deadlines October 15 and July 1, respectively).

The PhD in Nursing program prepares nurses for leadership roles in practice, education, and research, as well as to advance nursing knowledge through identification of nursing phenomena and the development and testing of nursing theory. The number and types of courses included in the program will vary according to the individual needs of the student. Students will normally be admitted in September and are addied to apply early (December/January) in order to qualify for scholarships. The faculty offers a variety of clinical, educational, and research resources. Graduate Assistantship opportunities are available for both MN and PhD students.

### University of Toronto, Faculty of Nursing

The Faculty of Nursing at the University of Toronto seeks two senior faculty members for tenure stream positions at the Associate or Full Professor levels. One will bring expertise in the nursing of acutely ill adults and the other will concentrate on nursing of acutely ill children. Expertise in oncology nursing is particularly sought, These individuals will play leading roles in the Faculty's new Ph.D. program in Nursing Science and in the research programs that support it. They will be expected to develop their research in collaboration with researchers and clinical nurse specialists in clinical agencies with which the Faculty is closely associated. A cross appointment to a clinical agency accompanies these faculty positions. Faculty research interests include: coping with chronic illness; working with difficult patients: family caregivers of chronically ill adults and children: health promotion with older adults; normal and high risk mothers and infants; and the quality of nursing worklife. Procedure: Please submit three double-spaced copies of the manuscript on 216mm x 279mm paper, using geneous margins. Include a covering letter giving the name, address, present affiliation of the author(s). It is understood that articles submitted for consideration have not been simultaneously submitted to any other publication. Please include with your article a statement of ownership and assignment of copyright in the form as follows: "I hereby declare that I am the sole proprietor of all rights to my original article entitled." and that I assign all rights to copyright to the School of Nursing, McGill University, for publication in The Canadian Journal of Nursing Research/La revue canadienne de recherche en sciences infirmières. Style and Format: Acceptable length of a manuscript is between 10 and 15 pages. The article may be written in English or French, and must be accompanied by a 100-200 word abbranct (if possible, in the other language). Please submit original diagrams, drawn in India ink and camera-ready. Prospective authors are asked to place references to their own work on a separate sheet and to follow the style and content requirements detailed in the Publication Manual of the American Psychological Association (7st. ed.), Washington, D.C: APA, 1983.

Manuscript Review: Manuscripts submitted to the journal are assessed anonymously by two members of a Review Board, using the following criteria:

#### Assessing content

Internal validity - relatedness: Is the problem the paper deals with identified? Is the design of the research or the structure of the essay appropriate to the question asked? Are the statistical, research and logical methods appropriate? Can the findings be justified by the data presented? Are the implications based on the findings?

External validity - relevance, accountability: Is the question worth asking? Is the problem of concern? Are there problems of confidentiality or ethics? Are the findings of the research or the conclusions of the essay significant? Can the findings or the conclusions be applied in other situations? Does the article contribute to knowledge in nursing? In what way?

### Assessing presentation

Are the ideas developed logically? Are they expressed clearly? Is the length appropriate to the subject? Does the number of references or tables exceed what is needed?

Publication Informations: On receipt of the original manuscript, the author is advised that the editional board response will be forwarded within ten weeks. When a manuscript is returned to the author for revision, three copies of the revised manuscript (dated and marked 'revised') should be returned to the delior within four weeks.
